INTRODUCTION

- A. Ours is a factory at Aluva, having HT IA Industrial Connection with 340kVA Contract demand.
- B. Our Company like to install 1No. 250kW WTG at Udumpanchola Taluk, Karunapuram Village, Idukki. We have submitted connectivity application with KSEBL on 22.10.2019 as a CPP Consumer. On 16.12.2020 we have received a letter from Chief Engineer, Distribution Central stating that we need to remit Rs.52,53,505/- towards IDC Charge along with Supervision charge for the establishment of 1no. 250kW WTG Project.
- C. Even though Power Department Policy Guidelines for development of Wind Power in Kerala through private developers (G.O.(Ms) No.18/2013/PD dated 22.04.2013), Power Department Policy Guidelines for development of Wind Power in Kerala through private developers, modified order issued (G.O.(Rt) No.57/2016/PD dated 04.03.2016) is available, KSEBL didn't consider the same and directed us to remit IDC Charge.
- D. As per Power Department policy, IDC Charge is limited to Rs.20lakhs per MW or actual expenditure whichever is less. But KSEBL is claim that IDC charge as per their estimate have to be remitted by us.
- E. In our Kerala State Regulatory Commission (Connectivity and Intra – State Open Access) Regulation 2013 dated 10.09.2013, Reg. 6 (6) *'The cost of construction/installation of dedicated line or the augmentation of the transmission or distribution system and associated facilities shall be borne by the applicant and the requisite steps to be taken in this regard shall be as mentioned in the State Grid Code or the State Supply Code or the State Distribution Code as the case may be'*. Hence the Regulation need to change according to the Power Department Policy.
- F. Fees Rs.10,000/- (Rupees Ten Thousand only) as per Annex II, Reg.18, schedule of fees see Regulation 64 (1) of Kerala State Electricity Regulatory Commission (Conduct of Business) Third Amendment Regulation 2014, is enclosed as DD drawn in favour of the Secretary, KSERC, payable at Trivandrum from
