Quotations will be opened by the Secretary at 11 am on the next working day.

Terms and Conditions

- 1. Rates quoted should be invariably for one year and from the date of approval and inclusive of all taxes, transportation charges etc.
- 2. No increase in rates will be accepted during the period of contract except Government taxes.
- 3. In case of any breach of contract, the firm will not be enlisted in future.
- 4. Delivery shall be made promptly on the basis of the supply order as required by this office.
- 5. Samples of items noted as good quality shall be attached with the quotation for verification.
- 6. Quality of items supplied shall be the same brand/trade mark during the period of contract as per the samples attached at the time of inviting the quotation. If any

article is found to be defective/or not up to the quality, the same shall be replaced immediately.

- 7. If any inferior quality of item is supplied/ items not supplied as per the specifications/ failure to supply in time etc., will entail the firm/company ineligible for future contracts with this office. The list of items to be supplied is shown as Annexure.
- 8. Normally, the Commission will purchase the articles from the selected bidders to meet requirements. At the same time Commission reserves its liberty to purchase any item from outside during the contract period.
